EXECUTIVE SUMMARY

Dear readers,

Daily life as a volunteer member in the board of MIJARC Europe is very busy. As soon as 2019 is over, we move on to the next year and its activities. That is why I am thrilled to present to you the activity report of MIJARC Europe and to look back at this challenging year 2019 and to report all our achievements.

For 24 years MIJARC Europe has carried out international activities for its member organisations, has offered them a platform to find partners, bilateral or multilateral projects and has represented their opinion at the European level. So did we in 2019.

2019 was the year of the elections of the European Parliament and of many national and local elections. That was a good reason to focus on citizenship and the participation of young people in political processes. The year started with a big challenge: our yearly local activity. Not only did we decide to organise one in 10 different countries but we also sent at least one MIJARC Europe volunteer in each country to facilitate the activity. It was a huge organisational and logistic task but we managed to bring closer together all our member organisations through deep exchanges between the volunteers of the country where the visit took place and the volunteers who facilitated it. The dedication and enthusiasm which our volunteers showed taking part in the local visits continued during the seminar and the summer camp. Both groups were amazingly involved in the activities, caring for each other, and gained great skills relevant to participation through empowering themselves and each other. Overall, MIJARC Europe offered an open agora to learn about participation in the society and discuss about the state of it in each country and organisation as well as a wonderful place to experience it in a tolerant and inclusive group atmosphere.

2019 was also a year rich in partnerships: the study session with Don Bosco Youth Net, the European manifesto with CEJA and Rural Youth Europe, the MIJARC World seminar with CIDSE and many other meetings. It was a pleasure to cooperate with different organisations, learn from each other's experience and learn new methods and contents.

All of this is only possible through the strong engagement of the board and the staff of MIJARC Europe. They are working all year long, looking for funds, organising the content of the activities, networking with partners to ensure the ideas and opinions of its member organisations will be heard, offering support to the member organisations and much more. For this reason, I would like to immensely thank Alexandra Solomon for her involvement in MIJARC Europe's staff from 2015 to 2019 and to warmly welcome Amalia Hammarlund who started in 2019 as Secretary General and to Sara Neagu who became a member of the board.




Who we are







ACTIVITIES

"LET'S HAVE A LOOK" – LOCAL VISITS –

From February to April 2019, MIJARC Europe organized focus groups, called “local visits” in 9 different countries: Armenia, Belgium, Bulgaria, France, Germany, Malta, the Netherlands, Romania and Spain.

The aim was to create a detailed analysis of the state of participation at local level in ten different rural areas of Europe, to be used as a starting point for further measures and actions.

Small groups of 10 to 20 people aged between 12 to 22 years old came together, sometimes also with representatives of local authorities, to discuss the topic of youth participation. The visits lasted two days and were led by either a member of the Board or by a commissioner.

ACTIVITIES

"LET'S HAVE OUR SAY" – SEMINAR –

The international seminar “Let’s have our say” took place between 8-11th July, in Kranevo – Bulgaria. It was a very successful activity and we believe this happened because of a mix of factors: the topic – youth participation; the tools used – the Charter and the “Have your say” manual; the results of the previous phase, the local visits; the dedication of the team of trainers and the involvement of the participants.

The aim was to help the young people and the youth organizations involved to gain confidence in their own capacity to influence decisions that affect their life and to gain trust in co-operating with public authorities. The evaluation results show that all the objectives were met with over 90%.





ACTIVITIES

"LET'S GO ONLINE" – SUMMER CAMP –

The third activity of the work plan was a training course on digital citizenship and e-participation. It took place in Overisje – Belgium, between 19-26 August 2019. The activity followed the broader aim of the work plan and focused on increasing the confidence of the young participants in their skills of using digital tools in order to participate and to make their voices heard.

The results of the evaluation forms reveal that this was a moderately successful activity that managed to achieve more than 70% of its objectives, which is a good result considering the profile of the participants (grass-root level volunteers and members with almost no experience in youth work).

Nine follow-up activities were implemented by the participants who attended the training course

- increased ability to integrate new forms, places and mechanisms of youth participation;

- over 70% of the participants more confident that they are able to help their organisation to use new forms, places and mechanisms of youth participation in their projects, programmes and practices.



#EVERYBREATHWETAKE – SOCIAL NETWORK CAMPAIGN

Launched on the last day of our training course, the #EveryBreathWeTake raising awareness campaign aimed to make young people more aware of the fires in the Amazon and climate injustice. The participants used the knowledge and tools they had gained throughout the training course and put them to good use in a campaign that had reached more than 100 people in the first week since its launch.

“Our common home is on fire. The Amazon is burning and we cannot hold our breath until you finally take action. What is happening in the Amazon is affecting us all over the world. It is a global emergency.

Will you watch the fire or will you support us in doing something? In putting pressure on the institutions which are supposed to protect our home and ACT?

Will you help us prevent this from happening again?

This is about #EveryBreathWeTake.

Challenge 3 more people to take a deep breath to remind us about the precious natural resource which is on fire. We need to keep the fight for Climate Justice!”




ACTIVITIES

"I, YOUTH ADVOCATE" – STUDY SESSION –

The study session "I, Youth Advocate" was a double study-session co-organised by MIJARC Europe and Don Bosco Youth Net (DBYN). It was held between 7th – 10th October 2019 at the European Youth Centre in Budapest.

It aimed to prepare young people from MIJARC Europe and DBYN Networks to be active advocates at European level, on diverse topics of interest for youth.

The study session was structured on two main phases: an e-learning phase and the residential phase of the study session. It was based on non-formal education methods and used a mixture of the methodologies used by the two host-organisation. The "See-Judge-Act" methodology of MIJARC Europe and the Don Bosco method promoted by DBYN.

"VOTE" – CAPACITY BUILDING PROJECT –

MIJARC Europe joined the Capacity Building project "Raising the capacities of youth NGOs for rural youth participation in democratic life – VOTE!".

As our annual priority topic in 2019 was youth participation, joining the activities of the project brought added values. MIJARC Europe sent its representatives to the activities and discussed the topic of participation and democracy.

The 1st contact making event was in Yerevan, Armenia between 28.02-06.03.2019, where we discussed the project and understood the flow and the roles of the partner organisations. After the preparatory meeting our representatives participated in the training course in Gozo, Malta (28.04-06.05.2019) and the international seminar in Bulgaria (28.04-06.05.2019).

The aim of the activities was to analyze the current situation in Europe; to discuss the role and importance of increasing the capacity of NGOs working with rural youth; to share practices in order to increase the political influence of the young generation; to develop their competence to successfully work with young people from rural areas; to create workshops that could be implemented locally.

The project is a long-term one and we will take part in the upcoming activities within it.


Overall we were happy to be surrounded by great partners and friends and strengthen the ties with other like minded people.









European Youth Forum - 1st Council of Members

12-13 April, in Brussels - Belgium

The YFJ's COMEM is a meeting where members are invited to make decisions on the direction, vision and positions of the Youth Forum. In April, the COMEM also hosted elections for the Advisory Council on Youth of the Council of Europe. MIJARC Europe is a full member of YFJ.



European Youth Forum - 2nd Council of Members

21-23 November, in Amiens - France

In November, our representatives took part in the 2nd COMEM, which was organized in the European Youth Capital 2020, Amiens, France. A new Strategic Plan of YFJ was adopted and the members discussed and voted on several Policy Papers and Resolutions.



General Assembly of ECVC

23 - 26 March, in Brussels - Belgium

MIJARC Europe was represented by one of its commissioners, Christian Genenger. The meeting was focused on topics related to agriculture and it helped MIJARC Europe to get to know organisations from all over Europe i.e. Ukraine, Ireland, The Netherlands



European Parliament Youth Network Event

7 March, in Brussels - Belgium

This event was organised by the Youth Outreach Unit as a kick off for setting up of the Parliament's own youth network. 84 participants attended the event, representing 70 youth organisations from all over Europe. MIJARC Europe was represented by its commissioners, Charlene Debrincat.

COMECE meeting



International Youth Forum Rome

19 - 22 June, in Rome - Italy

After the Synod on Youth in 2018 and the Pre- Synodal Meeting which we attended in April 2018, we were invited by the Holy See to a follow up activity. In Rome we discussed the outputs of the Synod on Youth and how to proceed with "Christus Vivit" together with 250 young people.



KLJB Partnership Summit

15-16 June, in Bonn - Germany

Every second year KLJB gathers all KLJB dioceses who are involved in an international partnership with another youth group. We used this weekend to exchange on the challenges we face, the ways of youth participation we experience and how we can help young people to be active citizens in their communities.

Meeting with Renovabis

19 June, in Freising - Germany.

Renovabis is the solidarity initiative of the German Catholics with the people in Central and Eastern Europe. Our board member, Claire, visited them at their headquarters in Freising to exchange on current projects and challenges and set some milestones for the future cooperation.

Rurbest European Rural Youth Parliament

04-06 November, in Asturias - Spain

The European Rural Youth Parliament gathered rural youth from Belgium, Bosnia and Herzegovina, Croatia, Czech Republic, Kosovo, Latvia, North Macedonia, Slovakia and Spain. They worked together to write a youth manifesto which was then presented in front of hundreds of stakeholders from all over Europe during the European Rural Parliament.

COMECE Social Affairs Commission

20 - 21 November, in Brussels - Belgium

The COMECE Social Affairs Commission gathered in Brussels to exchange views on key EU challenges towards integral ecology and a just transition. Our board member, Cristiana, held a speech about MIJARC Europe's position in the part of the meeting discussing "EU Common Agricultural Policy and Rural Development: towards an integral approach?"





Podcast - "How about YOU(th)"

The "Interconnected World" Commission decided to start a podcast called "How about YOU(th)". It is a Podcast where young people are talking about climate change and the change they are making.

MIJARC Europe is hosting this loudspeaker of young voices to let everybody know, that change is coming, whether they like it or not. In 2019 we published 6 bigger interviews with a young member from the European Parliament, climate activists sailing to Chile for the COP and many inspiring young people. During advent we published one short episode each day with 24 small impulses on sustainability.

MIJARC Explore Magazine

2 issues of the magazine were published in 2019. It is available in English, in digital and printed format.
